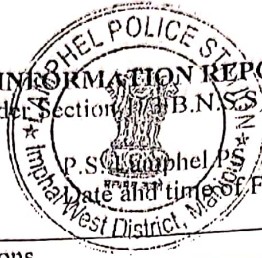

Subject: Complaint regarding assault on a public servant while on duty

I, Thongram Debajani Devi, DC, Dett 232 (M), hereby submit this complaint regarding an incident of assault on me while performing official duty.

On 15/06/2026 at about 1708 hrs, I was deployed for law and order duty at RIMS Hospital, Imphal, in connection with the agitation by members of the Naga community against the treatment of bullet-injured Kuki youths admitted in the hospital. During the course of duty, I was present with my team along with ASI Th. Kananbala Devi of Manipur Police near the Emergency Counter Booth and Patients' Waiting Area within the premises of RIMS Hospital. At that time, an unidentified Naga lady (suspected a kabui lady) agitator suddenly assaulted me by slapping me while I was discharging my official duties.

It is pertinent to mention that security forces had dispersed agitators gathered outside the premises by firing TSM due to the prevailing law and order situation. Immediately after the assault, I apprehended the said unidentified lady; however, taking advantage of the chaos and commotion at the spot, she managed to escape.

The above act amounts to assault on a public servant while performing official duty and obstruction in the discharge of official functions.

In view of the above, I request you to kindly register an FIR against the unidentified lady and take necessary legal action as per the relevant provisions of law. Necessary investigation may also be conducted to identify and apprehend the accused person. This complaint is submitted for your kind consideration and necessary action.
