Sir,

I have the honour to state that today i.e., 20/06/2026 at about 02:30 pm, a reliable information was received from our own source regarding the presence of some armed miscreants, in and around Langol area under Lamphel Police Station with a view to commit prejudicial activities. Based on the information and with the permission of the authority, a combined team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself and personnel of QAT 109 Battalion CRPF under the command of Shri P. Achouba Meetei, MPS, Dy. SP (CDO), IW and under the supervision of Shri. N. Suraj Singh, MPS, Addl. SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted search operation at Langol Leima Khullen Leikai area. During that one suspected person was detained at Langol Leima Khullen Leikai for verification. On spot verification, the detainee identified himself as Khundrakpam Seitabahon Singh (47 yrs.) @ Bon S/o. (L) Kh. Shanti Singh of Uripok Laikhurembi Leikai, Imphal West District, Manipur a/p at a quarter located at Langol Leima Khullen Leikai.

During preliminary verification, he disclosed that he kept concealed some arms and ammunitions in the said quarter (occupied by him) located at Langol Leima Khullen Leikai for the purpose of committing prejudicial activities.

Hence, he was arrested from the spot i.e. from Langol Leima Khullen Leikai at 04:55 pm by observing formalities.

From his possession, (i) one REDMI Note 15 Pro+ 5G mobile handset along with two SIM cards i.e., (a) one Jio SIM card bearing mobile no. 7005779321 (as disclosed by him) and (b) one Vodafone SIM card bearing mobile no. 9774504166 (as disclosed by him) was seized at the spot at 05:00 pm by observing due formalities.

As a follow up action as per the disclosure of the arrestee, the said CDO-IW team along with the arrestee rushed to the said quarter located at Langol Leima Khullen Leikai and as pointed out by him, a place located at the back yard of the said quarter was dug and after digging, one .32 pistol marked with "32 7.65" along with a magazine was recovered which was found inside three nos. of black plastic bag. Hence, the above recovered articles i.e., (a) one .32 pistol marked with "32 7.65" with a magazine and (b) three nos. of black plastic bag were seized at the said quarter at 05:57 pm by observing due formalities.

On thorough verification, the arrestee disclosed that he kept concealed another pistol in the bed room of the said quarter. As pointed out by him, one black plastic bag containing: (a) one .32 pistol marked with "MADE IN ITALY NO 1947 7.65" along with one magazine and (b) one white ammunition box containing 14 (fourteen) nos. of .32 ammunition were recovered which were kept concealed inside an almirah located in the bed room of the said quarter and the same recovered articles were later seized at the said quarter at 06:21 pm by observing due formalities.

On being asked about the above recovered arms and ammunitions, he disclosed that the said arms and ammunitions were bought from Phumlou area in the year around 2024.

Hence, the arrested person and the above seized articles are handed over to you for taking further necessary legal action.

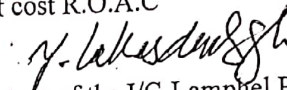

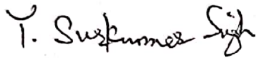
