I have the honour to state that today i.e. 25/06/2026 at about 03:45 pm, a reliable information was received from our own source and further corroborated from the information input provided by 33 AR regarding the presence of some active cadres of UNLF (P) organization (a faction of UNLF organization), an outlawed banned organization in and around Sangaiprou area of Imphal West District. Based on the information and with the permission of the authority, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW assisted by W/Inspector Shamjetsabam Sarjubala Devi of CDO-IW and myself under the command of Shri P. Achouba Meetei, MPS, Dy. SP (CDO), IW and under the supervision of Shri. N. Suraj Singh, MPS, Addl. SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted search operation at Sangaiprou area. During that one suspected person along with a Tata Safari DiCOR black in colour bearing registration number MN04A 4696 was detained at Sangaiprou FCI road near ISKCON Temple for verification. On spot verification, the detainee identified himself as Md Azad Khan (46 yrs.) S/o. (L) Md Islauddin of Borayangbi Thongkha, Bishnupur District, Manipur. During preliminary verification, he disclosed that he is an active member of UNLF (P) organization (a faction of UNLF organization) and started working for the said organization since July, 2023 and he was allotted LM (Local Member) No. 179 of UNLF (P) organization. He also disclosed that he is presently working under the command of one s/s Sergeant Major Puyalakpa (Ph. No. 9383096033 / 8798804245) of UNLF (P) organization from Andro side who is presently staying in Kakching Khunou area. Further, he disclosed that he is involved in illegal selling of arms for the purpose of committing prejudicial activities. He further disclosed that he shared some photos of arms to different people by using his mobile handset for the purpose of selling arms. Hence, he was arrested from the spot i.e., from Sangaiprou FCI road near ISKCON Temple at 05:55 pm by observing due formalities. From his possession, (i) one realme C30 mobile handset along with two SIM cards i.e., (a) one Airtel SIM card bearing mobile no. 7085342192 (as disclosed by him) and (b) one Jio SIM card bearing mobile no. 9366417459 (as disclosed by him), (ii) one Aadhaar card bearing no. 9140 4791 4281 and (iii) one Tata Safari DiCOR black in colour bearing registration number MN04A 4696 along with its key and one vehicle registration certificate bearing no. MN 04A 4696 were seized from the spot at 06:02 pm by observing due formalities.

Hence, the arrested person and the above seized articles are handed over to you for taking further necessary legal action.
