Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted search operation at Sangaiprou area. During that one suspected person was detained at FCI Godown, Sangaiprou for verification. On spot verification, the detainee identified himself as Koijam Lamyamba Meitei (23 yrs) @ Punshiba @ Ningol S/o. (L) K. Loken Meitei @ Sunita of Yairipok Malom Mamang Leikai, Thoubal District, Manipur.

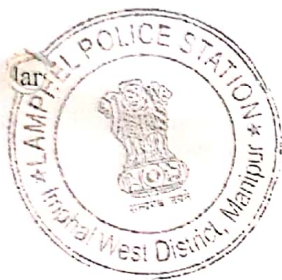
