Sir,

I have the honour to state that on 19/06/2026, at about 1:00 pm, my father, Shijagurumayum Romesh Sharma (60 years), was riding his Honda Pleasure Plus scooter, proceeding from Tera Bazar towards Naoremthong.

When he reached Tera Lukram Leirak, near Coffee Shop, a grey Maruti Swift Dzire without any registration number, which was parked on the roadside, driven by Asem Vibeckraj Singh (22 years), S/o Asem Tomba Singh of Keirno Langdum Makha Leikai, suddenly opened the driver's side door without ensuring that the road was clear. As a result, my father collided with the open door, causing him to sustain serious head injuries and the scooter was also partly damaged. He remains unconscious and is currently undergoing medical treatment.

After the accident, the driver of the said vehicle assured us that he would bear all the medical expenses incurred for my father's treatment. However, he has now refused to take any responsibility and has declined to provide any financial assistance. The report couldn't be submitted on time while engaging in medical treatment.

Therefore, I respectfully request your good office to kindly register this report, conduct a thorough investigation into the matter, and take appropriate legal action against the driver in accordance with the law. I also request that necessary steps be taken to ensure that justice is served.

I shall remain grateful for your kind consideration and necessary action.
