Sir,

I have the honour to report that today i.e. the 12th June, 2026 at about 4:00 a.m. received a reliable information from our own source corroborated with the intelligence of 2 JAK LI about the presence of an active member of the outfit KCP at Langjing Achouba area of Imphal West. Based on the said information and with the permission/authorization of the authority, teams of CDO/IE Unit conducted a C.I. Ops. at the said area under the command of Inspt. Anilchandra Mutum, Officer-in-Charge CDO/IE Unit, supervised by Shri. Y. Joyraj Singh, Addl. SP(Ops)IE and under the overall supervision of Shri. Shivanand Surve, IPS, Superintendent of Police Imphal East District at 5:00 a.m. after providing prior information to Imphal West District Police.

In that, one suspicious person was detained for spot verification and checking at Langjing Achouba, near HIMS (Hijam Irabot Memorial School), Imphal West. On checking the detainee body, one mobile phone was found and recovered from his possession. On verification, the detainee identified himself as one *Sagolshem Leishemba @ Ibungo (28 years) S/o (Late) S. Tomba Singh of Singjamei Wangma Beigyabati Leikai, Porompat Police Station, Imphal East District A/p Langjing Achouba, Lamphel PS, Imphal West*. On further verification, the detainee stated that he is an active member of the outfit KCP (Nongdrenkhomba) group joined through one Mr. Amujao of KCP (Nongdrenkhomba) group in the month of October, 2024 and presently working under the command of one Mr. Alin @ Adi of KCP (Nongdrenkhomba) group. The detainee further stated that under the command of the said Mr. Alin @ Adi of KCP (Nongdrenkhomba), about seven months before he along with other five of his associates allegedly fire out multiple rounds of ammunitions to a car and assaulted the driver of the car, Mr. Loyalakpa at Hatta Kounapat area of Imphal East District in connection with the monetary demand made by their outfit.

Further the detainee stated that, last month (June, 2026) he along with the said Mr. Alin @ Adi and one of their associate Mr. Bela of KCP (Nongdrenkhomba) allegedly kidnapped one person from Porompat Ayangpalli Road, Imphal East for ransom. The detainee is also involved in extortion of money from the general public, coaching centre and mobile phone stores located at Imphal West District for raising their party fund on the advice of the said Mr. Alin @ Adi of KCP (Nongdrenkhomba) group.

So, the detainee was arrested from the spot i.e. Langjing Achouba, near HIMS (Hijam Irabot Memorial School), Imphal West at 6:04 a.m. and seized *one mobile phone (Redmi Note 14 pro) bearing IMEI1: 868358078462903 & 868358078462911 along with one Airtel SIM card having phone no.9862902536* from the possession of the arrestee at the spot i.e. Langjing Achouba, near HIMS (Hijam Irabot Memorial School), Imphal West at 6:09 a.m. by observing due formalities

Therefore, the arrested person along with the seized mobile phone is being handed over to you for taking up further necessary legal actions against him.
