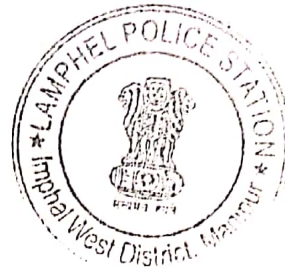

I have the honour to state that, today i.e. 15/07/2026 at around 12:30 pm, received an input that some miscreants are moving with arms at the area of Khurai Lairik Yengbam Leikai, Imphal East District with an intention to commit prejudicial activities. Immediately, teams of the Special CDO Unit, led by OC, SPL/CDO Unit, Khabeisoi and assisted by HC. Hijam Omega Meitei of Special Commando conducted search operation in the said area and detained one suspected person from near Napankhong Community Hall, west side of the Lamlong Thong (bridge). Khurai, Lairikyengbam Leikai, Imphal East District. The person identified himself as Sanjrambam Khunjaoba Meitei (54 years), S/o. (L) S. Kesho Meitei of Khurai Lairikyengbam Awang Leikai, Imphal East. On spot questioning, he disclosed that he kept one gun to one Mr. Laishram Sonamani Meitei (53 years) S/o. L. Suren Meitei @ Chaoba of Khurai Lairikyengbam Awang Leikai. On body search, one Samsung Galaxy A35 5G bearing airtel sim No. 7085054664 is found from his possession. Hence he was arrested at the spot at about 1:45 pm and seized the item at about 1:50 pm. After arresting him, our teams rushed at the residence of Laishram Sonamani Meitei at Khurai Lairikyengbam Awang Leikai, Imphal East. At the residence, our teams asked Laishram Sonamani Meitei to bring out the said gun which has been given by Sanjrambam Khunjaoba Meitei. Laishram Sonamani Meitei brings out one polythene plastic (transparent in colour) from the top of the wall pillar. On checking the polythene plastic (black in colour) the following items have been recovered- (i) One (1) suspected .38 ~~Pist~~ silver in colour with black grip panel bearing no visible mark, (ii) two (2) nos. of pistol magazines. (iii) Seven (7) nos. of live ammunitions bearing the head stamp markings '71' & '93' on the base of each ammunition. (iv) three (3) nos. 9mm live rounds ammunitions. (v) one (1) no. of live Insas rifle ammunition. (vi) three (3) Nos. of Pistol firing pins. (vii) three (3) Nos. of 9mm empty cartridges cases. and (viii) two (2) nos. of fired bullet heads (projectiles). Hence, he was formally arrested at about 3:20 pm and seized the articles at 3:25 pm by observing legal formalities. Both of them have been using the weapon in threatening the public.

Both the arrested persons and the seized items are hereby handed over to you for taking further necessary legal action.
