1. That, I am eldest son of (L) S. Jamkhogin Ngaihte who expired in the year 2020. My said father was the recorded pattadar of an Ingkhol class of land measuring an area of .0239 Hectare under New Patta no. 3016/3114/3549 corresponding to Old Patta no. 79/Ang covered by C.S. Dag No. 2660/2741/2891 situated on the Eastern Side of Langol Housing Complex within Revenue Village No. 91 – Meitei Langol. In my said father's landed property, we constructed a One storey concrete residential building and settled there till the outbreak of the ongoing ethnic violence.
  2. That, my said residential building remains intact for more than 2 (Two) years until I recently came to learn that on 27th March, 2025 at around 12:00 Noon, all the furniture and household materials inside my said building including my said deceased father's PPO Book and many official and personal documents were stolen and the building was also vandalized and fully damaged. The value of the building alongwith the stolen articles such as Beds, Benches, Chairs, Almirahs, TV, Washing Machine, Modular Kitchen, Refrigerator, Air Conditioner, Tube Well, CCTV, Pucca fencing, iron & steel gate, etc may be estimated at 1.5 Crore (One crore Fifty Lakh) only as the said building was completed in the year 2020 and the household materials of latest models and designs were newly purchased only after the completion of the building.
- I therefore report this matter to you as I am not in a position to approach the Lamphel Police Station with a request to register a case, investigate into the matter and take legal action against the culprits.
