On 4th May, 2023, our newly constructed house and household belongings at Joseph Colony, Meitei Langol (PS-Lamphel), were left unattended under lock and key when our family had to leave and flee for our lives with barely a few clothing sufficient for 2-3 days. Since then, we have not had any access to our house due to the ongoing turmoil in the Imphal valley.

2. This morning (July 26), a reliable source informed me that our house and belongings has now been completely demolished or looted with only pillars standing. Photos of this proof is enclosed herewith. Location of my house as shown in Google is also enclosed herewith.

3. Our house was constructed in 2021-22 with an approximate cost of Rs. 95 lakh and furniture and other household belongings worth Rs. 20 lakh were left behind unattended due to the ethnic clashes in Imphal.
