I, undersigned with reference to above cited subject have the honour to file this First information Report which I do as under-

2. That, I belong to Zou Tribe and I lived at a rented house owned by Sh. Pouzen Goumei located at Neikanlong, Thanmeiband, Imphal West, PO-Imphal, P.S- Lamphel, Manipur- 795001. I continually stayed at this address from 2004 till the Meeitei- Kuki conflict started in May 2023.

3. That, soon after the outbreak of Communal Conflict on 4th May 2023 at about 2200 hrs, some unidentified Meitei miscreants suspected to belong to the Arambai Tenggol attacked all Kuki houses of our locality including my house and looted and destroyed everything that I have owned. A rough estimate of the loss caused by the said attack is given below:
