1. That, in the month of April, 2025 the said **Bebika Akoijam** along with her biological mother namely Akoijam Tamphasana Devi (accused number 2) came to my residence and told me that the 6 years old daughter of **Bebika Akoijam** was diagnosed with cancer and she needed huge amount of money for the medical treatment of her daughter. And they asked me to lend some money and in that exchange the said Bebika told me that she will deposited some of her gold ornaments to me. And the above referred persons came to my residence along with some gold ornaments on different dates and gave those gold ornaments to me on those dates and I also gave them Rs. 15.45,000/- (Rupees fifteen lakhs forty-five thousand) and in total to the said persons on their request out of humanity ground on different dates. And the said Bebika even promised me that she will return back or repay the said amount of money.
2. That, the said Bebika promised me that in the month of July, 2025 she will return/repay the said amount of money and collect her gold ornaments to me. But till date she did not turn up and give the said amount of money.
3. That, on her failure to return back the said amount of money, I have decided to sell out the gold ornaments which she deposited. So, I went to a goldsmith store at Sega Road, Jailer Leirak to sell the gold ornaments and while checking/measuring the gold ornaments were made not by genuine gold it was fake/imitated gold ornaments. Then, I called the said accused person No. 1 to my house to talk about the matter. She along with her husband came to my house. And made known about the status/position of the imitated gold ornaments. She also admitted that all the gold ornaments which were given by her to me were fake/imitated gold ornaments. So, I want to inform that the said Bebika and her biological mother namely Akoijam (O) Tamphasana Devi dishonestly induced me to deliver the huge amount of money and breached the trust for our family relationship thereby causing harm to my body, mind, reputation and property. So, I request you to take appropriate legal action to the said persons for the ends of justice.
