Prakash Singh, under the command of Subedar Yengkhom Shaktishen Singh, OC/CDO Kakching, under the supervision of Shri Amarjit Singh Lamabam, MPS, Addl. SP (Ops), Kakching, and under the overall supervision of Smt. Priyadarshini Laishram, IPS, Superintendent of Police, Kakching, immediately rushed to the said suspected location and cordoned off the area and conducted frisking and checking passes by at Eco Park road near Nongjubi Changpham, Kakching. During the frisking and checking noticed one individual which was coming by foot from Tejpur side towards Kakching Garden in a very suspicious nature. Due to his suspicious nature the said individual was detained for verification.
