Brief of the case:

The brief fact of the case is that on 24th April, 2026 at around 6:30 am, a huge contingent of Tangkhul militant, NSCN-IM group attacked the village of Mullam, Ukhrul District. So, in order to save their lives, the complainant namely Mr. Letkhothang Haokip (47) yrs. s/o Ngamjathong Haokip and his family left their house along with their household belonging. During the process the Tangkhul militant, NSCN-IM burnt down the complainant residential house including all his household items like Furniture, electronic items, Kitchen items and other valuable properties and documents.

Hence, a case has been registered under FIR No. 0(11)(6)2026 KPI-PS u/s 351(2)/326(g)/324(4)/3(5) BNS & 25(1-C) A. Act and transfer to OC/Litan-PS as the PO fall under its jurisdiction.

Accordingly, a regular case under FIR No. 54(07)2026/LTN-PS u/s 351(2)/326(g)/324(4)/3(5) BNS & 25(1-C) A. Act was registered for investigation (Corrs. to Zero FIR No. 0(11)(6)2026 KPI-PS).

That I, Mr. Letkhotang Haokip, is a permanent resident of Mullam Village, Ukhrul District, Manipur, PS-Litan.

That on 24th April, 2026, at about 06:30 am, a huge contingent of Tangkhul militant, NSCM-IM group attacked our village. So, in order to save our lives, we left our house with all our belongings, and in the process they burnt down my house including all our household items.

I regret that I could not report the matter in time due to the communal issue between the two communities, as Mullam Village is under the Jurisdiction of Litan Police Station, Ukhrul District, Manipur.

I therefore, humbly request you to kindly register an FIR about my grievances so that my loss is compensated.
