As endorsed, I made an enquiry into the matter of complaint submitted by Mr. David Thanglum Mang Valte (30) yrs s/o Vungzagin Valte of Niangzen Khualbuk, Dorcas veng, New Lamka, Churachandpur regarding threat to the life of his father, creation enmity or communal disharmony between the Kukis and other communities.

As per my enquiry, the allegation made by the complainant was found to be true and genuine. During the occasion of Tollaipao Meet, from 5 – 10 January, 2026 held at Lhungjang Village, Saikul, Kangpokpi District, One S/S President KLA/KLO namely L. Jacob Kuki on his public speech stated that "Vungzagin Valte, MLA, 56 Thanlon AC was attacked at Imphal due to his identity i.e. Kuki. Now he is recovering and could not even speak due to the brutal attack and if he is still not accepting Kuki nomenclature, it's better to kill him off." The statement made by the said individuals promote enmity between different groups, hate speech and criminal conspiracy. Hence an FIR needs to be registered against S/S President KLS/KLO namely L. Jacob Kuki for swift and proper investigation.
