4	Brief of the work done																						
	1) On 06/07/2026, joint team of District Police, Jiribam and personnel of 48 Bn. CRPF conducted frisking and checking at Nungkhal Bridge, Jiribam and arrested one Md. Abdullah Hussain 22yrs. S/o Imani Mia of Mullargao at about 05:50 p.m. and recovered one country made .32 Pistol with magazine and 06(six) live rounds of .32mm ammunition. In the follow up action another accused person who is associate of the arrested person namely, Md. Anamul Haque 24yrs. S/o Md. Joynul Haque of Kashimpur, Jiribam A/P Pangkotphai village, Tamenglong District. A case with FIR No. 18(07)2026 JBM PS U/s 310(6) BNS & 25(I-B) A. Act was registered at Jiribam P.S. and investigated into. The arrested accused persons are remanded into judicial custody on 18/07/2026. 2) on 17/07/2026 at about 10.30 a.m. received a reliable information that one person namely Mr. Kulla who was doing business of contraband Ganja at his own house located at Lakhipur Chingkha, Jiribam Accordingly, acting on the information District Police Jiribam led by ASP(LO), Jiribam under the supervision of SP Jiribam conducted search of Mr. Kulla in the various vicinity places at Jiribam area. Then on the same day at @ 11.55 am. Mr. Kulla was found at Jiribam Bazar near fish market and detained him. Thereafter, the said detainee was identified himself as Konjengbam Kulla Singh aged about 47 yrs S/o (L) K. Biren Singh of Lakhipur Chingkha Ward No. 9, Jiribam. Further, after due process of ND & PS Act, the house of the said Mr. Kulla Singh was searched and one packet wrapped with blue colour polythene containing dried herbs in compact is found kept on the table and another 3 (three) plastic container (white in colour) are also found concealing under the table. On, opening of the																						

		said packets it is found containing dried herbs in compact highly suspected to be contraband Ganja weighing 56.750 kgs and arrested Mr. Kulla at 3.10 pm of 17/07/2026. 3) On 22/06/2026 at about 02:20 a.m. received an information regarding the presence of one PLA cadre namely, Mr. Shamurailatpam Sanjit Sharma @ Thoi @ John aged about 30 yrs S/O S. Shanti Sharma of Kalinagar Ward no. 3, Jiribam at Kalinagar Ward No. 3, Jiribam. Acting on the information, joint team of District Police, Jiribam personnel of 20th Bn. CRPF, 156th Bn. CRPF, 48th Bn. CRPF, 87th Bn. CRPF and of 38th Assam Rifle under the supervision of SP Jiribam conducted search Ops. However, the individual was not found at his house and learnt that he is staying at his uncle's house namely Shamurailatpam Gourakishor Sharma located at Bakhal Manipuri Basti, Jirighat, Cachar, Assam. Since, the village Bakhal is in Assam under Jirighat P.S. As such, OC/Jirighat Police Station has been communicated. In due of time, the joint team with the assistance of Jirighat Police raided the house of Shamurailatpam Gourakishor Sharma at @ 5.05 am in which one unknown person later identified himself as Shamurailatpam Sanjit Sharma @ Thoi @ John aged about 32 yrs S/O (Late) S. Shanti Sharma of Kalinagar Ward no. 3, Jiribam could be arrested. On questioning the individual disclosed that he is an active cadre of RPF/PLA and he joined the said unlawful organisation in the year 2022 under the direct command of one S/S. Lieutenant Colonel Krishna @ Lai @ Ingo and presently working under the command of one cadre Manao of RPF/PLA. He further disclosed that he also directly involved in recruitment of new cadres and extortion for raising fund of the organisation. As such, he was arrested at 05:15 a.m. and recovered one mobile smart phone model Oppo A6 5G (off black in colour) along with one Airtel SIM card bearing mobile no. 9282767023. A case with FIR No. 21(07) JBM PS U/S 13/17/19 UA(P) A. Act was registered for investigation.
