Noor Kamaal Sheikh (MPS), SDPO, Jiribam with a team of Jiribam -PS, CDO/Unit, Jiribam, OC/CDO-Unit, Jiribam, CDO/Imphal West, Special Mobile Patrol Unit, Jiribam, 7th IRB, QAT-48 Bn. CRPF, QAT-87 Bn.
