**Subject: Report.**

Sir,

I have the honour to state that, today i.e., 12/08/2026 at about 5.00 am, when I was at NAB-PS, Manipur one of my source man informed me that, one person namely Ahmad Hussain 44 yrs s/o Seraj Ahmad of Keirao Makting Awang Leikai, Irilbung Police Station, Imphal East District, Manipur is selling heroin powder to the local drug users and kept a huge quantity of heroin powder inside his room for selling purpose. The said information was reduced in writing and placed before the Superintendent of Police/NAB, Manipur. Then, I along with a team of NAB-PS, Manipur and a team of MN Sector QAT and Range Imphal QAT CRPF along with all the necessary equipment was constituted for execution of the secret information.

The combined team of NAB-PS, Manipur and a team of MN Sector QAT and Range Imphal QAT CRPF moved towards the residence of Ahmad Hussain 44 yrs s/o Seraj Ahmad of Keirao Makting Awang Leikai, Irilbung Police Station, Imphal East District, Manipur in the department vehicle TATA Yodha bearing No. NIL along with the source man and necessary equipment & documents. *While reaching the spot, the combined team found a person who was identified himself as Ahmad Hussain 44 yrs s/o Seraj Ahmad of Keirao Makting Awang Leikai, Irilbung Police Station, Imphal East District, Manipur at the veranda of the house.* Accordingly, I briefed about the provisions of section 50 NDPS Act, 1985 in Manipuri language to the detainee and told him that I have reasonable ground of believe to have concealed narcotics drugs inside his house and was informed that he has legal right under section 50 NDPS Act to be searched before Magistrate/Gazetted Officer or Civil/Independent witnesses, if he so desire. A notice u/s 50 NDPS Act was also served to him in which he told that, he opted to be searched before civil witnesses.

Further, I requested nearby civilians to witness the house search in which two witnesses namely Ruqsana Shahani 18 yrs d/o Majibur Rahaman of Keirao Makting Awang Leikai and Khallir 38 yrs s/o (L) Nasimudin of Keirao Makting Awang Leikai agreed to witness the same. In presence of the witnesses, the combined team started house search of Ahmad Hussain 44 yrs s/o Seraj Ahmad of Keirao Makting Awang Leikai, Irilbung Police Station, Imphal East District, Manipur. On further checking, *one black polythene likely to contain suspected heroin powder was found kept under the almirah near his bed. Accordingly, the combined team detained Ahmad Hussain 44 yrs at his residence along with the detected suspected heroin powder.* In the meantime, a requisition was submitted to Scientific Officer, Mobile Forensic Unit, Lamphel, Imphal West for deputing a team of Mobile Forensic Unit, Imphal West District, Lamphel.

As it seems to be created tension among the local people which may cause harm to the detainee and the police team while conducting legal procedures, the detainee along with the detected drugs were brought at the premises of Irilbung Police Station, Imphal East District, Manipur for the safety of the accused person and the police team while conducting legal procedures. After some while, as requisited a team of Mobile Forensic Unit, Imphal West District led by Scientific Officer Inaobi Singh Maibam reached at the premises of Irilbung Police Station and started conducting legal procedures. On opening the black polythene packet, found one 100 ml bottle and 18 vials containing suspected heroin powder. The 18 vials were marked as A1, A2, A3 to A18 and the 100 ml bottle was marked as B for

identification. The team of MFU took a small pinch of suspected heroin powder from the bottle and vials which are marked B and A1, A2, A3 to A18 respectively for conducting field testing by using the field-testing kit brought by them and gave positive result of heroin powder. After taking out negligible amount of heroin powder from the 18 vials marked A1, A2, A3 to A18 and the bottle marked B for the purpose of chemical testing at laboratory, 18 vials were put in a small transparent polythene packet. On weighing, the 18 vials marked A1, A2, A3 to A18 containing heroin powder weighed 25 grams including the weight of the vials & the transparent polythene packet and the 100 ml bottle marked as B containing heroin powder weighed 20 grams including the weight of the bottle. **After weighing, the 18 vials marked A1, A2, A3 to A18 containing heroin powder weighed 25 grams including the weight of the vials & the transparent polythene packet and the 100 ml bottle marked as B containing heroin powder weighed 20 grams including the weight of the bottle along with the polythene packet black in colour were put in a yellow paper envelope marked as "P" which is properly packed and sealed with wax by using the facsimile of OCNAB PS, Manipur.**

In presence of the witnesses, one yellow paper envelope marked as "P" which is properly packed and sealed with wax containing heroin powder weighing 25 grams including the weight of the vials marked as A1, A2, A3 - A18 & transparent polythene packet and one 100 ml bottle containing heroin powder weighing 20 grams including the weight of the bottle and one polythene packet black in colour (altogether weighed 45 grams including the weight of the vials and the bottle) were seized from the possession of Ahmad Hussain 44 yrs s/o Seraj Ahmad of Keirao Makting Awang Leikai, Irilbung Police Station, Imphal East District, Manipur at the spot on the same day at 11.00 am by preparing a weighing and seizure memo.

Further, one mobile phone Oppo A15 bearing mobile No. 9612330117, one Aadhar card bearing No. XXXX XXXX 3466 and a sum of Rs. 280/- (rupees two hundred and eighty) only were also seized on production by Ahmad Hussain 44 yrs s/o Seraj Ahmad of Keirao Makting Awang Leikai, Irilbung Police Station, Imphal East District, Manipur at the spot on the same day at 11.05 am by preparing a seizure memo.

Accordingly, Ahmad Hussain 44 yrs s/o Seraj Ahmad of Keirao Makting Awang Leikai, Irilbung Police Station, Imphal East District, Manipur was arrested at the spot on the same day at 11.10 am by preparing an arrest memo.

The whole process of seizure and arrest was video graphed in my eSakshya account. I gave intimation about the arrest of the accused persons to his wife namely Bilkish and intimated the accused person about the ground of his arrest. I took the signatures of the arrested accused person and witnesses in the parent exhibit, weighing and seizure memo, seizure memo and arrest memo and I also put my signatures on the same.

Hence, the arrested accused persons along with the seized items are handed over to you for taking necessary actions.
