Subject: Report.



Sir,

I have the honour to state that, today i.e., 23/08/2026 at @ 9.30 am while I along with a team of NAB-PS, Manipur was on random frisking and checking in an around the area of North AOC along NH-2, Imphal West District, Manipur, one TATA Winger white in colour bearing regd. No. MN03BA 0241 was found parked in front of Mao-Imphal Market, Temporary Shed, Imphal West District, Manipur. While checking the TATA Winger, found a blue colour bag under the first row of passenger seat on the right side and at the same time one person identified the driver to the police team. On asking about the blue colour bag the driver and the owner of AIR Rajdhani Travels Counter informed the police team that, it was belong to **Yumkhaibam Zakir Hussain aged about 38 yrs s/o Y. Kayam of Lilong Konjil Makha Leikai, Thoubal District, Manipur** who was also a driver of a TATA Winger of Sangai Travels, North AOC, Imphal West District, Manipur. On checking and opening the blue colour bag, found 3 (three) brown plastic packets suspected to be containing brown sugar which were kept wrapping by a grey colour pant.

After identifying ourselves as police officer and personnel of NAB-PS, Manipur, I requested nearby civilians to witness the search and seizure procedure in which no one agreed to witness the same and at the same time two personnel from my police team voluntarily agreed to witness the same. In the meantime, a requisition was submitted to Scientific Officer, Mobile Forensic Unit, Lamphel, Imphal West for deputing a team of Mobile Forensic Unit, Imphal West District, Lamphel. Accordingly, a team of Mobile Forensic Unit, Imphal West District led by Scientific Officer Inaobi Singh Maibam reached at the spot i.e **Mao-Imphal Market, Temporary Shed, IW District, Manipur**. The team of MFU took out the blue colour bag which was kept under the first row of passenger seat on the right side and marked "A" for identification. On opening the blue colour bag, found some clothes and within the clothes found 3 (three) brown plastic packets suspected to be containing brown sugar which were kept wrapping by a grey colour pant. The grey colour pant was marked as "B" for identification and on removing the 3 (three) brown plastic packets suspected to be containing brown sugar were marked "B1", "B2" and "B3" for identification.

The team of MFU took out negligible quantity of suspected brown sugar from the packets marked "B1", "B2" and "B3" for field testing by using the field-testing kit brought by them and for chemical analysis at laboratory. The field testing gave positive result of brown sugar. On weighing, "B1", "B2" and "B3" containing brown sugar weighed 1.007 kgs, 1.009 kgs and 0.986 kgs respectively (total 3.002 kgs) including the weight of the plastic packets.

In presence of the witnesses, One white gunny bag marked as "C" which is properly packed and sealed with wax containing 3 (three) brown plastic packets marked as "B1", "B2" and "B3" containing brown sugar weighing 1.007 kgs, 1.009 kgs and 0.986 kgs respectively (total 3.002 kgs) including the weight of the plastic packet and one TATA Winger ticket from AIR Rajdhani Travels dated 23/08/2026 in the name of Jakir departing Imphal to Dimapur were seized at the spot on the same day at 11.22 am by preparing a weighing and seizure memo.

Further, one TATA Winger white in colour bearing No. MN03BA 0241 was seized on production by the driver namely Md. Arif Shah 28 yrs s/o Md. Rafi Khan of Yairipok Shikhong Khunou, TBL District a/p Mantripukhri Mother teressa at the spot on the same day at 11.27 am by preparing a seizure memo.

The whole process of seizure and arrest was video graphed in my eSakshya account. I took the signatures of the witnesses in the parent exhibit, weighing and seizure memo, seizure memo and I also put my signatures on the same.

I along with a team of NAB-PS, Manipur including Woman Police conducted house search at the house of **Yumkhaibam Zakir Hussain aged about 38 yrs s/o Y. Kayam of Lilong Konjil Makha Leikai, Thoubal District, Manipur** but he was not found in his house. During the house search no seizure or arrest was made.

Hence, the seized items are handed over to you for taking necessary actions.
