**Brief of the case:**

Received a transferred Zero FIR from Officer-in-Charge, Kangpokpi Police Station bearing Zero FIR No. 0(5)(3)2026 KPI-PS U/s 324(4)/61(2)/326(g)/3(5) BNS, 25(1-C) A Act & 5 Expl. Subs. Act 1908. The case originates from a written complaint lodged by Mr. S. Janginthang Vaiphei, aged 38 years, son of S. Lhunsei Vaiphei, a resident of Mongkot Chepu Village, PO/PS-Litan, Ukhrul District, Manipur.

The brief fact of the case is that on 24/03/2026 at around 7:30 a.m., Tangkhul militants carried out heavy gunfire towards the complainant village Mongkot Chepu village, PO/PS-Litan, Ukhrul District, Manipur. During the attack the bomb struck the complainant house, causing severe property damage and putting his family at risk.

Hence, a case has been registered by OC/Kangpokpi Police Station under Zero FIR No. 0(5)(3)2026 KPI-PS under the aforementioned provisions and transferred the case to OC/Litan Police Station, as the Place of Occurrence (PO) falls under its territorial jurisdiction.

Upon receipt, a regular case under FIR No. 59(09)2026/LTN-PS u/s 324(4)/61(2)/326(g)/3(5) BNS, 25(1-C) A Act & 5 Expl. Subs. Act 1908, was registered for investigation (Corrs. to Zero FIR No. 0(5)(3)2026 KPI-PS).
