12. First Information contents:

Brief of the case:

Received a transferred Zero FIR from Officer-in-Charge, Saikul Police Station bearing Zero FIR No. Zero 6(3)2026 SKL-PS, U/s 310/324/109/3(5)/61(2) BNS, 25(1-C) A. Act & 3 Explosive Substance Act. The case originates from a written complaint lodged by Miss. **Lh. Phelneichin Mercy Khongsai**, aged 36 years, daughter of Lh. Paokam, a resident of Mongkot Chepu Village, Ukhrul District, Manipur.

The brief fact of the case is that on 24/03/2026 at around 7:30 a.m., during the morning school shift at Mongkot Chepu Village, Tangkhul armed militants launch an attack in the area, and school premises fell well within the effective firing range. Explosives struck the school infrastructure, and stray bullets endangered the lives of students and staff, causing severe life threat and significant psychological trauma to all present.

Since the Place of Occurrence (PO) falls within the territorial jurisdiction of Litan Police Station, OC Saikul Police Station registered the matter under Zero FIR No. Zero 6(3)2026 SKL-PS and transferred the case to OC Litan Police Station for investigation.

Upon receipt, a regular case under FIR No. 60(09)2026/LTN-PS u/s 310/324/109/3(5)/61(2) BNS, 25(1-C) A. Act & 3 Explosive Substance Act, was registered for investigation (Corrs. to Zero FIR No. Zero 6(3)2026 SKL-PS).

Subject: Request for registration of FIR regarding militant attack on 24/03/2026.

Respected Sir,

I, Lh. Phelneichin Mercy Khongsai, Principal Secretary of Indira Gandhi Hill Flower School and an eye-witness, hereby lodge this complaint for registration of case regarding a militant attack that occurred on 24th March 2026 at around 7:30 A.M during the morning school shift at Mongkot Chepu Village.

During the incident, Tangkhul armed militants launched an attack in the area, and the school premises fell well within the effective firing range. The school infrastructure was struck by explosives, and stray bullets endangered the lives of students and staff present at that time.

The incident posed a serious threat to life and has caused significant psychological trauma to all present at the time.

I am submitting photographic evidence of the attack and resulting damage.

I request that an FIR be registered immediately to take appropriate necessary legal action be initiated against the armed militant and also to kindly ensure adequate security for the school and surrounding area.
