Subject: FIR/Complaint regarding death by electrocution due to negligence.

Respected Sir,

I, the undersigned, wife of late Daniel (30) s/o Talu of Maram Ramlung Village, would like to submit this complaint for your immediate action.

That today i.e on 02/09/2026, the youth of Maram Ramlung village were carrying out electric cable laying work and removal of old naked wires within the village. this work was undertaken after obtaining proper understanding and permission from the concerned department and after confirming a complete power shutdown from the in-charge of Power House, Maram.

While the work was in progress, the power supply was suddenly and unexpectedly restored without any prior intimation or warning by the in-charge of power house, Maram. As a result of this gross negligence, my husband, Late Daniel, was electrocuted at about 2:33 pm today.

It is therefore most humbly requested to kindly investigate the matter thoroughly as to how and why the power was restored without any information, despite knowing that work was in progress. It appears that the act was done intentionally with an ulterior motive.

I therefore request you to register an FIR and take strict Legal action against the culprit responsible for this inhuman and negligent act.

For this act of your kindness, I shall remain ever grateful.
