With reference to the subject cited above, I would like to bring to your notice that my wife, Smt. Khomdram Roznus, had gone to Aztechs Fight Studio Gym, located at Ghambir Singh Shopping Complex, Thangal Bazar, Imphal in the morning of 28th August, 2026, on my Steel Grey TVS Jupiter bearing Registration No. MN06SK-8659, Engine No BK4FR3103046 and Chassis No. MD626AK 49R3F22923, which is registered in my name.

At about 6:17 AM, she parked the said vehicle in front of Ghambir Singh Shopping Complex, near Classic Kitchen Restaurant, and secured the vehicle properly under lock and key before entering the gym.

At about 7:10 AM, upon coming out of the gym, she found that the said vehicle was missing from the place where it had been parked. Despite making an immediate search in the nearby area, the vehicle could not be located.

I therefore suspect that the vehicle may have been stolen by some unknown person/persons during the aforesaid period. I request you to kindly register the matter, take necessary legal action, and make all efforts to trace and recover the vehicle. I also request that the CCTV footage available in and around Ghambir Singh Shopping Complex, particularly near Classic Kitchen Restaurant, may kindly be examined to identify the person/persons involved.
