Sir,

I have the honour to report that on 31/8/2026 at about 9 am, I along with my wife Likmabam Romita Devi 35 years w/o L. Santosh Singh, resident of Wangjing Wangkhei, Thoubal District left our residence to visit her parental home located at Khangabok Bangshibudon.

Upon reaching her parental home, I dropped her off and proceeded to my workplace at SP office Thoubal to attend to my official duties. After completing my official work for the day, I returned to my wife's parental home at around 04:00 pm to pick her up and to return our residence.

Upon my arrival, her parents informed me that she had been missing from the house since 4:00 pm approx. We have searched her in and around residential premises as well as throughout the neighboring localities. Moreover, it is also informed that she had not returned back to her matrimonial home. We have also contacted all our mutual relatives, friends and acquaintances to trace her. Despite our best and frantic efforts, her whereabouts remain completely unknown.

Given the sudden, uncharacteristic and highly unusual nature of her disappearance, I have strong reasons to suspect that she may have been abducted from her parental house by unknown miscreants and is wrongfully confined at an undisclosed location against her will.

It is therefore requested to kindly take necessary action in this regard.
