Today i.e. 29/08/2026 at about 11:20 pm, reliable information was received that on the same day at around 11:10 pm, one Maruti Alto car, silky silver in colour, bearing Registration No. MN02A-0841 driven by an unknown driver was proceeding from Wangjing side towards Khongjom side. On reaching near Uningkhong Bridge along NH-102 the said Maruti Alto car knocked down one unknown pedestrian. After the accident, the unknown driver of the vehicle fled from the spot. As a result of the accident the unknown pedestrian sustained serious injuries on his person and evacuated to District Hospital Thoubal for medical treatment and declared brought dead by the concerned doctor. The Maruti Alto car was also found to have sustained extensive damage in the accident.

Hence a regular suo-motu case under FIR No. 37(08)2026 KJM PS U/S 281/125(b)/324(4)/106(1) BNS 2023 has been registered for investigation.
